The McLeod County Agricultural Association will use diligence to protect livestock and articles entered for exhibition after their arrival and placement, but under no circumstances will it be responsible for any loss, injury or damage done to or caused by any exhibit. It is the responsibility of the exhibitor to obtain the appropriate insurance for any damages due to or caused by the exhibit and to indemnify and hold the Agricultural Association harmless against any claim arising out of the incidents involving the exhibit. Removal or pick up of exhibits at established times as stated in department premium lists, shall be the responsibility of the exhibitor. The Agricultural Association shall not be responsible for any exhibit not removed or picked up at the established times. Any exhibit not picked up within the established time will be disposed of within 30 days. Perishable items will be disposed of the next day following the close of the fair if not claimed. Entry forms must be signed. If entrant is under the age of 18, entry form must be co-signed by a parent or guardian. I have read all general rules and regulations of competitive exhibitors in the Premium Book and agree to comply with all listed rules. Failure to do so will result in loss of premium and potential termination from exhibition in future years.
